We do not endorse Republicans, but when you don't have the option to vote for a Democrat, your vote for a less concerning Republican will help prevent far-right Republicans from being elected. **We have listed certain concerning far-right candidates in RED and we strongly recommend against voting for these individuals.** Some candidates have (D/R) after their name, which means they won both the Democratic & Republican primaries through cross-filing or write-in votes.
